

## MEDICAL DIRECTOR OR ADMINISTRATOR SUBLIMTS OF LIABILITY ENDORSEMENT

In consideration of the premium, solely for the purpose of the coverage provided by this endorsement, the policy is amended as follows:

I. The Professional Liability Limits of Liability Section on the **COI** is amended to include the following Schedule:

Each Medical Director or Administrator claim Sublimit of Liability	\$100,000
Aggregate Medical Director or Administrator claim Sublimit of Liability	\$300,000

- II. The Professional Liability Coverage Part is amended as follows:
  - A. Section III, Coverage Part Definitions is amended as follows:
    - i. The following definitions are added:

**Administrative services** mean planning, organizing, directing, and controlling operations within the scope of duties of a medical director or administrator. However, **administrative services** does not mean the provision of medical care or treatment of patients.

**Medical director or administrator claim** means a written demand for **damages** made against an **insured** arising out of or alleging **administrative services** provided by a medical director or administrator.

ii. The definition of **claim** is amended to add the following:

Claim also means a medical director or administrator claim.

- iii. **Insured** also means:
  - 1. the facility medical director or administrator but only for **administrative services** performed on behalf of the **named insured**; and
  - 2. solely with respect to **medical director or administrator claims**, a physician.
- iv. The definition of **professional services** is amended to add the following:

## Professional services also mean administrative services.

- B. Solely with respect to **medical director or administrator claims**, the DIRECTOR OR OFFICER LIABILITY Exclusion in Section IV, Exclusions Applicable To All Coverage Parts of the General Terms and Conditions is deleted with respect to a natural person **insured** while performing **administrative services** on behalf of the **named insured**.
- C. Section V, Coverage Part Limits Of Liability And Related Claims is amended to add the following:

Medical Director or Administrator Claims – Sublimits

1. Each Medical Director or Administrator Claim Sublimit of Liability

Notwithstanding the Limits of Liability stated on the **COI**, the each **medical director or administrator claim** Sublimit of Liability shown on the Schedule above is the most we will pay for



all **medical director or administrator claims** arising out of any one **wrongful act** or any **related wrongful acts**. The each **medical director or administrator claim** Sublimit of Liability is part of, and not in addition to, the Professional Liability Limits of Liability shown on the **COI**.

## 2. Aggregate Medical Director or Administrator Claim Sublimit of Liability

Notwithstanding the Limits of Liability stated on the **COI** and subject to provision 1. Immediately above, the aggregate **medical director or administrator claim** Sublimit of Liability shown on the Schedule above is the most we will pay for all **medical director or administrator claims**. The aggregate **medical director or administrator claim** Sublimit of Liability is part of, and not in addition to, the Professional Liability Limits of Liability shown on the **COI**.

All other terms and conditions of the Policy remain unchanged.

This endorsement, which forms a part of and is for attachment to the Policy issued by the designated Insurers, takes effect on the effective date of said Policy at the hour stated in said Policy, unless another effective date is shown below, and expires concurrently with said Policy.
